



## Job Description

**POSITION TITLE:** Operations Manager

**REPORTS TO:** Chief Operating Officer (CEO)

Exempt

Non-exempt

**Job Summary:** The Operations Manager oversees Sarasota Medical Pregnancy Center's (SMPC's) operations and ensures a smooth day-to-day functioning of the organization.

### Job Functions:

1. **Administrative Duties**

- Manager in support of Center-wide coordination of services.
- Support CEO and manage Center in CEO's absence.
- Oversee goal setting, project planning, and training scoping of Center programs.
- Oversee State program funding and grant management by coordinating budgets, staffing, invoicing, and reporting to meet state criteria.
- Promote the Center within the community.
- Collect and record monthly statistical data from client records and submit to the CEO for reporting to the Board of Directors.
- Complete and submit yearly statistical data to CEO for Care Net requirements (in February of each year).
- Annual review of medical components of Center policies and procedures. Update as necessary and submit to CEO for Board of Directors' approval.
- Oversee orientation and training of new nurse volunteers and provide medical related training to other volunteers.
- Participate in medical related segments of new volunteer training sessions at Center Services Manager's request.
- Support relationship building with other medical facilities.

2. **Medical Services Operations**

- Oversee all medical services and Nurse Manger.
- Oversee review of client records and quality assurance with the Nurse Manager.
- Serve as a resource for client advocates, nurse volunteers, and other volunteers.
- Comply with State and professional licensing regarding continuing education requirements.

3. **Client Care Oversight and Support**

- Ensure consistency of client care throughout SMPC.
- Advise managers to help them achieve annual goals and provide staffing oversight.

#### 4. **Emergencies**

- Emergency calls – refer to a local hospital emergency room, the caller’s own private physician, or advise to call 911.
- Consult the Medical Director as needed.
- If there is a medical emergency on-site, follow the procedures for medical emergencies.

#### **Minimum Qualifications:**

- College degree
- Community Health experience

#### **Preferred Qualifications:**

- Professional or medical license
- Prior Management or Leadership Experience in a pregnancy center and/or LCSW Supervision

#### **Additional Eligibility Qualifications:**

1. Committed Christian who demonstrates personal relationship with Jesus Christ as Savior and Lord.
2. Exhibits strong commitment and dedication to the pro-life position.
3. Agree with and be willing to uphold the Code of Conduct and policies of the Center.

#### **Physical Requirements:**

Sitting regularly over 2/3 of day

Standing occasionally 1/3 of day

Talking/Hearing regularly over 2/3 of day

Reaching frequently 1/3 to 2/3 of day

Use of hands to finger, handle or feel frequently over 2/3 of day

Lifting occasionally up to 25 pounds

#### **Travel:**

Travel for this position is minimal but may include travel to local meetings.

#### **Working Conditions:**

Office/Indoor environment
